If you have been a PA resident for 10 years or more, you will need the following:

- 1. Pennsylvania Child Abuse History Clearance
- 2. Pennsylvania State Police Criminal History Clearance
- 3. Signed Affidavit of Volunteer form (see Page 2)

If you have not lived in PA for the last 10 years, you will need the following:

- 1. Pennsylvania Child Abuse History Clearance
- 2. Pennsylvania State Police Criminal History Clearance
- 3. Federal Bureau of Investigations (FBI) Criminal History Clearance

It's very possible that you can obtain a copy of your valid clearances from your church office. PA State Clearances are valid for 5 years.

Although NJ laws are much less stringent, we are asking those from NJ churches who work with children at any district event to have these same 3 background checks done and filed with your local church office.

6.	I further attest and certify that I have not been convicted of an offense designated as a felony under the Controlled Substance, Drug, Device and Cosmetic Act.
